

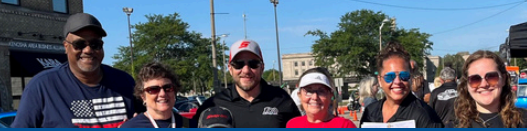

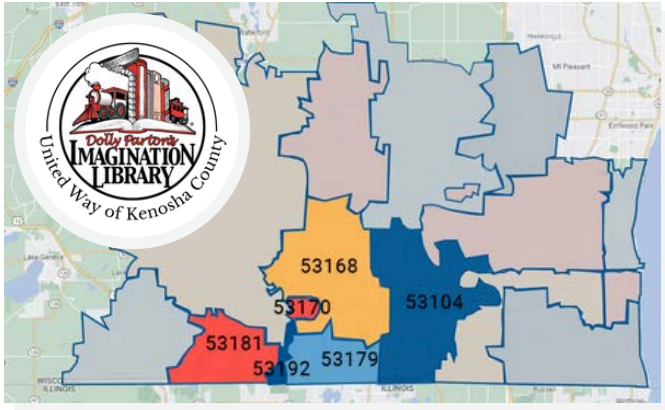
## Volunteer Income Tax Assistance (VITA)

VITA provides free income tax preparation to Kenosha’s low to moderate income residents. VITA has helped bring back \$23M in tax refunds to over 13K taxpayers since 2010. 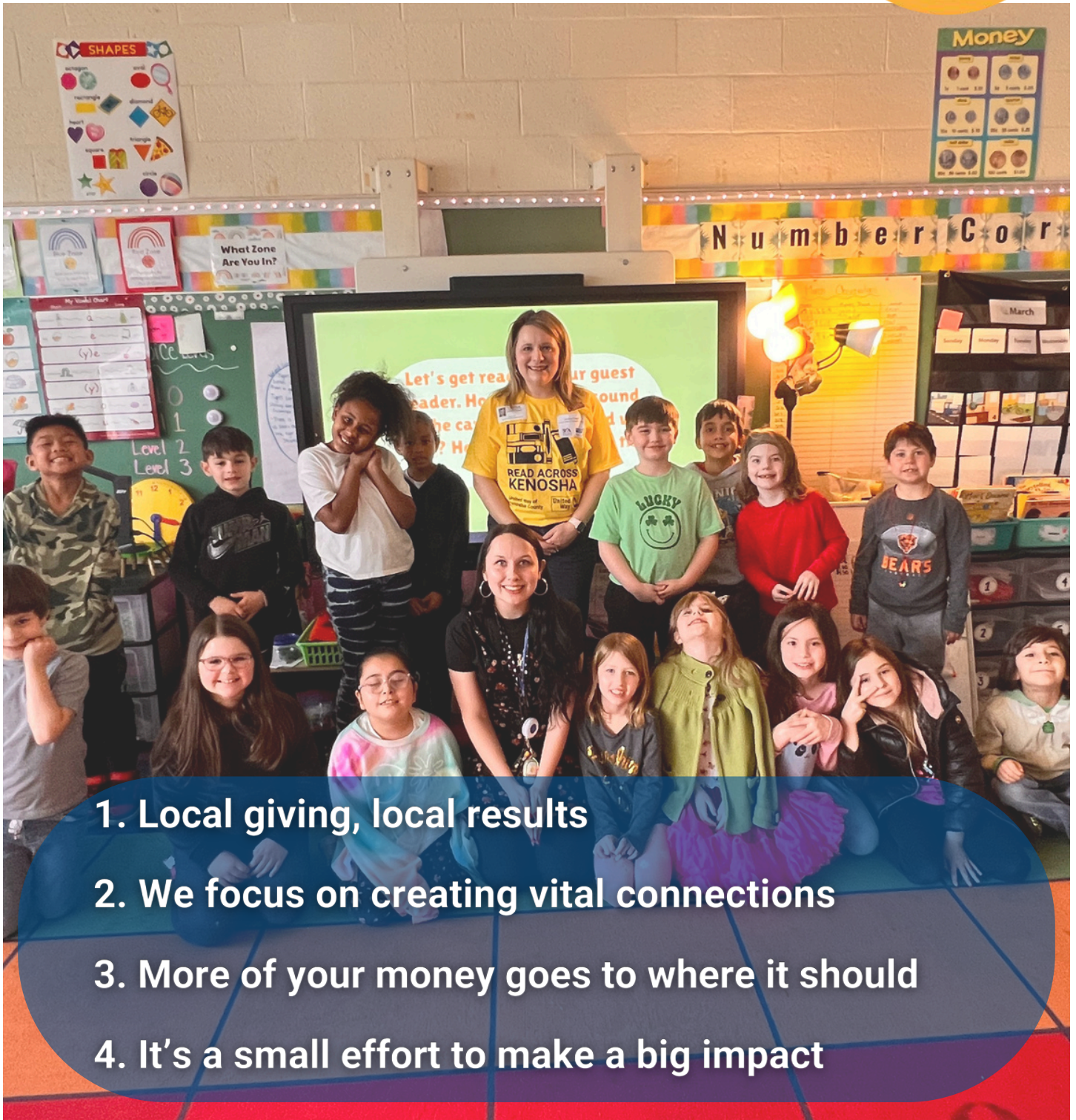
